


1 Traffic Flow Diagrams


- 1.1.1 A series of junction flow diagrams showing AM and PM peak hour traffic flow diagrams for 2029 and 2039 future assessment years. The AM peak hour is considered to be 7.30am-8.30am and the PM peak hour assessed is 5-6pm on a typical weekday. The following scenarios are presented in the figures below:
 - Do Minimum the future baseline without the Proposed Scheme. This
 includes committed developments and highways improvements.
 - Do Something the future situation with the Proposed Scheme added.
 - Do Something + Mitigation the future situation with the Proposed
 Scheme added with an additional package of traffic interventions in the wider network north of A1067 and south of A47.




Figure 1-1 2029 Do Minimum AM Peak



















Figure 1-2 2029 Do Minimum PM Peak



















Figure 1-3 2029 Do Something AM Peak





















Figure 1-4 2029 Do Something PM Peak



















Figure 1-5 2029 Do Something + Mitigation AM Peak



















Figure 1-6 2029 Do Something + Mitigation PM Peak



















Figure 1-7 2039 Do Minimum AM Peak



















Figure 1-8 2039 Do Minimum PM Peak



















Figure 1-9 2039 Do Something AM Peak



















Figure 1-10 2039 Do Something PM Peak



















Figure 1-11 2039 Do Something + Mitigation AM Peak














Figure 1-12 2039 Do Something + Mitigation PM Peak
