




1 Introduction

- 1.1.1 The plans enclosed present the general arrangement of the A47 North Tuddenham to Easton Dualling Scheme proposed by National Highways.Firstly an overview plan is shown dated December 2020 which illustrates the full scheme extents.
- 1.1.2 This is followed by more detailed plans from the National Highways DCO application which was approved in August 2022. The plans include the point of connection between the Proposed Scheme and the Strategic Road Network, where a new grade separated junction would be constructed to replace the existing at grade junction of A47 with Wood Lane and Berrys Lane.
- 1.1.3 Other changes to the road layout and Non-Motorised User routes at the southern edge of the Proposed Scheme area also shown including a proposed underpass beneath the new A47 dual carriageway which would connect with the Non-Motorised User provision for the Proposed Scheme.


